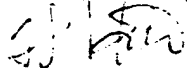

Dear Dr. Strangway,

Dr. Albert McLean of your Office has informed me that my request for a formal investigation into the general conduct of Dr. Maria Klawe as Head of Computer Science, including her handling of the job application of Dr. Pascal van Hentenryck, is under your consideration. I wish to re-iterate that Dr. Klawe has committed serious mistakes and wrongdoing during her tenure as Department Head which have caused damage not only to her victims including myself but to the Department of Computer Science as a whole. I feel strongly that the University should relieve Dr. Klawe of her Head duty immediately and should urge Dr. Klawe to take remedies to rectify her mistakes.

I fully understand your reluctance to open such an investigation or to adopt disciplinary measures since Dr. Klawe was appointed by you to head the computer Science Department. However, any indecision on your part on this matter would only inflict more damage on the University of British Columbia. I am convinced my opinions on this matter are shared by many faculty, staff, students of the Computer Science Department, who have not had adequate opportunities to express their feelings. I therefore shall on my own hold a meeting with members of the Computer Science Department to solicit their opinions and forward them to your Office to assist you in reaching a wise decision.

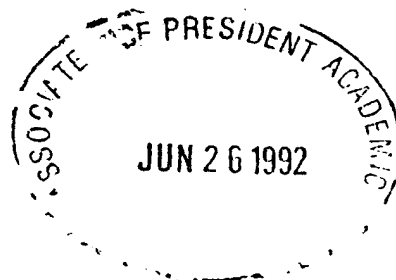

The Meeting

The wrongdoing, misconduct and mistakes by Dr. Maria Klawe as Head of Computer Science have caused serious damage to the Computer Science Department and should be stopped and rectified at once. I have informed President Strangway my wish to hold a Meeting of Department Members to address the relevant issues and to forward to him your opinions. This meeting will take place at 11 am, Friday, June 26, in CSCI 301. In particular, discussions and votes will be conducted on the following questions:

- a) Were there violations of code of conduct by Dr. Klawe in her handling two years ago of my job application and of the job application of Dr. Pascal van Hentenryck?
- b) If wrongdoing was committed, should Dr. Klawe write to me and to Dr. van Hentenryck to formally admit her mistakes?
- c) Should the President conduct a thorough investigation into the general conduct and performance of Dr. Klawe as Head of Computer Science?
- d) If serious wrongdoing, misconduct and mistakes are found on the part of Dr. Klawe as Department Head, should the University relieve her of her Head duty immediately?

My own stand is "Yes" to all these questions.

Meeting of Department Members

This morning at 11:30 a faculty brown-bag lunch meeting was held with the first topic on the agenda the issue of cheating by some students in graduate courses. It was abruptly and unreasonably terminated by Dr. Klawe when I insisted on a discussion about holding a Department Meeting to address cheating on the part of the Department Head in her handling of departmental affairs.

There is no question that cheating by a student should not be tolerated, but cheating by the Department Head, who is at a much higher professional level and occupies a much more important professional position, is infinitely more deplorable and causes very damaging consequences to the Department as a whole. The plights of Dr. Pascal van Hentenryck and myself are testimonies to this. This issue is of utmost importance to the Department of Computer Science and must be addressed at once. Someone who committed such acts of dishonesty and inflicted such damages on individuals as well as on the Department should not be allowed to continue as the Head. Since Dr. Klawe has steadfastly refused to hold a Department Meeting on this topic and the Dean's instructions have made it impossible for the faculty members who are sympathetic to my cause to organize one, I am calling another Meeting of Department Members at 11 am, Tuesday, June 30, in CSCI 301, to address the relevant issues. In particular, discussions and votes will be conducted on the following questions:

- a) Were there violations of code of conduct on the part of Head of Computer Science, Dr. Maria Klawe, in her handling two years ago of my job application and of the job application of Dr. Pascal van Hentenryck?
- b) Should the President conduct a formal and thorough investigation into the general conduct of Dr. Klawe as Head of Computer Science?
- c) If serious wrongdoing, misconduct and mistakes are found on the part of Dr. Klawe, should the University relieve her of her Head duty immediately?

The resolutions of this meeting will be forwarded to the President's Office to assist President Strangway in making his decision on this matter.

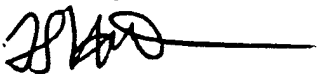
