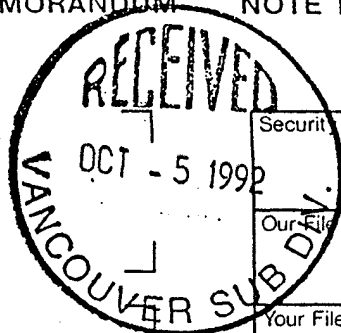

Correspondence dated 92-09-04 your office refers.

A formal investigation was initiated as a result of the copy of the Fax forwarded by the Public Complaints Commission. The operational file at the University Detachment was reviewed and Dr. GAO was immediately contacted to arrange an interview at a future date.

Dr. GAO was contacted on two further occasions in an attempt to arrange an interview with him. During one of these calls, GAO's position seemed to be softening, as he indicated that we may very well have been justified in our actions, but he was interested in learning about what others at U.B.C. had told our office about him. He was advised that my mandate was only to deal with the two isolated allegations involving the actions of our members.

On 92 Sept 28 Dr. GAO was called and a meeting was requested. At this time he advised that he was prepared to withdraw his complaint. An offer was made to attend and have him sign a Form 1442 indicating his intent to withdraw his allegations, but he chose to almost immediately forward this office a signed P.C.C. withdrawal Form.
