Dr. Feng GAO v. Her Majesty the Queen et al

Your correspondence to the C.O. "E" Division 93 January 06 refers.

While Dr. GAO's correspondence to the Solicitor General somewhat describes our involvement in this occurrence, I summarize events here for your information and referral.

On July 2, 1992 the assistance of members of the University of British Columbia Detachment, R.C.M.P. was requested to remove Dr. GAO from his office and to relinquish his keys as a result of his non-compliance to his cessation of employment and direction to vacate his offices. This apparently was the culmination of a long standing feud between Dr. GAO and the University concerning his tenure at the institution.

Following his removal and surrendering of keys Dr. GAO filed a complaint with the Public Complaints Commission on 92.08.11, their file 2000-PCC-92639 against the members at the University Detachment alleging misconduct in the performance of their duties, abuse of authority and remarks which were considered racist in tone.

An internal investigation was commenced in this regard however on 92.09.28 Dr. GAO withdrew his complaint with the Commission.

On 92.10.06 Dr. GAO filed a Writ of Summons against the University of British Columbia, Her Majesty the Queen and the University Detachment, R.C.M.P, B.C.S.C. Registry #C926136. The Federal Department of Justice Vancouver was consulted in this regard and their counsel have been assigned to represent the force and our interests in this continuing action.

As requested, a copy of our correspondence to Dr. GAO is attached.
