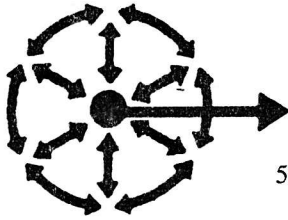

Case Conference Service Plan
Held: 21 September 1993

Referred Person: Gao, Feng Birth Date: 29 January 1959

Service Plan: Those present agreed to the following:

Legal:

Any court order should include

- 1) A no contact order for all areas of the University of British Columbia and Health Sciences Hospital - University Site;
- 2) A condition related to counselling at the Forensic Outpatient Clinic; and
- 3) Periodic reviews by the judge.

Dave Phillips agreed to circulate copies of the court order to the University of British Columbia, Health Sciences Hospital - University Site, the University of British Columbia Detachment of the Royal Canadian Mounted Police and the South Mental Health Team.

Treatment:

Should Mr. Gao present at Health Sciences Hospital, he will be assessed and treated as required for urgent medical problems.

In instances where there is not an urgent medical need, he will be asked to seek treatment at an alternate appropriate resource. If he refuses to leave, a charge of Breach of Probation is recommended.

Suicide threats will result in certification and referral to the Forensic Psychiatric Institute.

The Forensic Outpatient Clinic will be notified of any contact by Mr. Gao with the Health Sciences Hospital.

Other:

Dave Phillips will meet with Mrs. Gao to outline the discussion at the case conference, explain what is occurring legally and solicit her support of the plan.

Those participating are asked to keep the M.S.N. apprised of their involvement with Mr. Gao. The M.S.N. will monitor Mr. Gao's situation and update workers as required.
